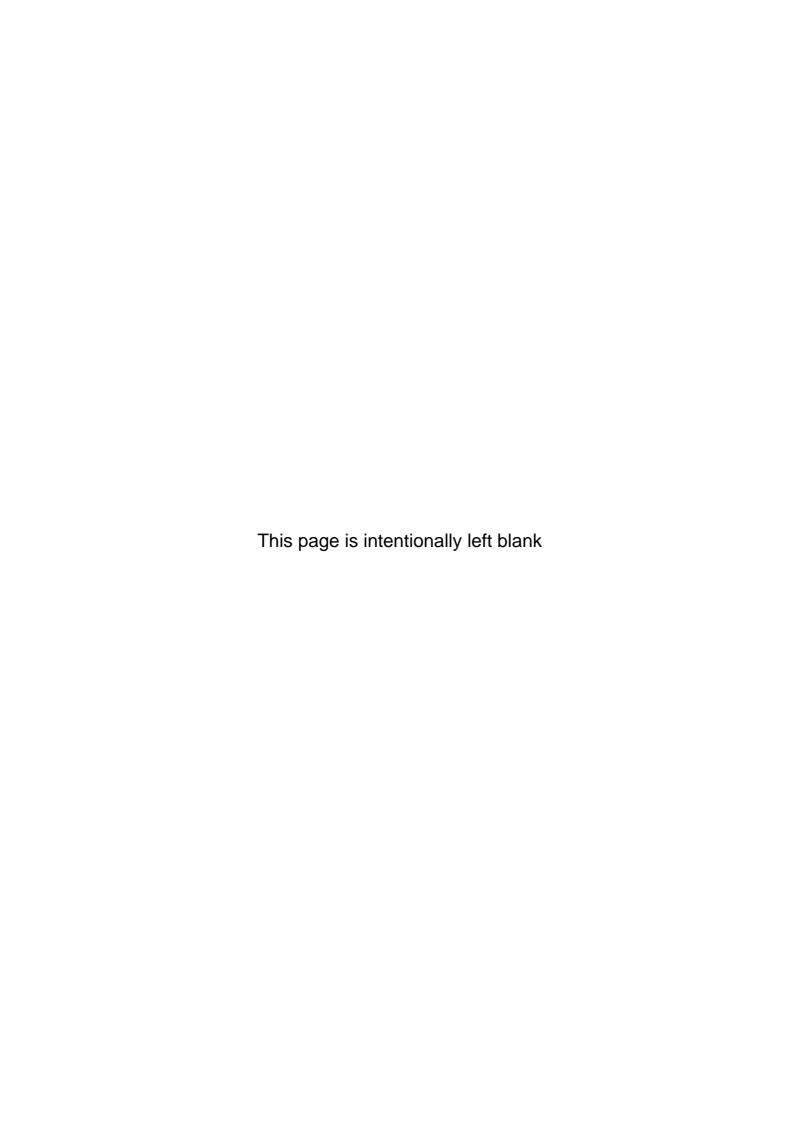

#### REPORT FROM THE DIRECTOR OF CORPORATE STRATEGY

# CORPORATE GRANTS PROGRAMME 2005/06 FOR DECISION

This report presents how the Corporate Grants Programme will be allocated in 2005 / 2006.

#### **Summary**

This report provides proposals on how the Council's corporate grants programme will be utilised to support local voluntary and community sector organisations in 2005 / 2006. This corporate grants programme has been evaluated in a context of a cash budget of £550,300 and a rent in kind budget of £128,560. It has also been undertaken within the context of a revised assessment process where each application has been assessed in relation to its capacity to deliver the Community Priorities and cross-cutting targets identified in the revised Community Strategy and in terms of Impact Assessments.

#### Recommendations

The Executive is asked to agree to:

- 1. The allocation of the grants programme managed by the Corporate Strategy Department as set out in Appendix 1 of this report;
- 2. The additional conditions of grant aid on community cohesion as set out in Appendix 1 of this report; and
- 3. The allocation of the grants programme managed by the Social Services Department as set out in Appendix 2 of this report.

#### Reason

This report requires Executive approval in order to allocate the Corporate Grants Programme funding, and make decisions on the Council budget.

# 1. Background

1.1 The corporate grants programme has been an established way for the Council to support voluntary sector organisations in the Borough in meeting local and national priorities. There is a compelling case to retain the Corporate Grants Programme, which can be summarised as follows:

- CPA 2002 Corporate Assessment indicated the need to build more effective partnership arrangements, ensuring that the voluntary sector are clear about their role and build their capacity to deliver Community Priorities;
- Voluntary sector organisations who receive funding from the programme are then able to seek matched funding from a range of sources, which encourages inward investment and enhanced service delivery in Barking and Dagenham;
- As a means in which to influence direction of service delivery; and
- Strong external stakeholder expectations to capacity build the voluntary and community sector, particularly in relation to services to communities who may be excluded or hard to reach through existing mainstream services.
- 1.2 In November 2003, The Management Team (TMT) received a report on the revised process for managing the corporate grants programme linking funding arrangements to the Community Priorities and the revised Community Strategy. This focus requires a willingness to dispense with previous custom and practice which may have based funding decisions upon a tradition of supporting organisations because they have always received financial support, rather than because they are best placed to meet the Council's objectives and priorities.

# 2. The Corporate Grants Programme delivery process

- 2.1 The process of establishing who should receive a corporate grant in 2005 / 2006 arises out of the context of the report agreed at the Executive in May 2003, on the 2004 / 2005 programme. At this meeting it was agreed that health and social care organisations would be funded by Social Services Financial Spending Share (FSS) if they were to receive grant support. It was also agreed that those delivering education services would be funded by Education FSS. Social Services do provide very substantial funding for the voluntary sector through contracts, a list of which is attached along with an explanation of the support that the department provides to the voluntary sector (see Appendix 2). Funding of organisations from the corporate grants budget is based upon their priorities and performance improvement requirements (see appendix 1).
- 2.2 The Voluntary Sector Team has worked jointly with the Corporate Equalities and Diversity Team to carry out a comprehensive equalities and diversity impact assessment as an integral part of the grant award process. This is designed to ensure that decisions are fair and equitable and that there is no adverse impact upon specific parts of the local community. This year the Corporate Equalities and Diversity Team have also taken the lead in managing the grants process with regard to the Black and Minority Ethnic (BME) community and have provided advice and guidance in incorporating clear equalities and diversity and community cohesion targets in the grant conditions. These processes are designed to ensure that the Council are delivering on its equalities and diversity objectives and meeting its statutory obligations under such legislation as the Race Relations (Amendment) Act 2000 and the Disability Discrimination Act (1995).
- 2.3 All other applications to the corporate grants programme were assessed in relation to their capacity to deliver the Community Priorities and the revised Community Strategy. All groups applying had to go through the following process:

- Submission of grant application;
- Review of the capacity of the proposed service to deliver the Community Priorities:
- Impact assessment on each application, to assess capacity to meet the needs of all members of the community and promote equality and diversity;
- Review of previous monitoring data and performance results where available;
- Assessment visit by the link council officer to determine the organisations capacity to deliver the services outlined in the application; and
- Recommendation on whether application should be supported.
- 2.4 The overall amount applied for from the Corporate Grants Programme for 2005 / 2006 from the 63 applications received from voluntary sector organisations in the Borough was £1.35m. This compares to grant provision available from the Corporate Grants Programme of £550,300.
- 2.5 Appendix 3 is the list of funded organisations 2004/2005

#### 3. Financial Implications

3.1 There is provision for £550,322 in the Corporate Strategy 2005 / 2006 budget in respect of cash grants to Voluntary Organisations. In addition there are rent in kind payments of £128,560 being made to voluntary organisations.

#### 4. Conclusion

- 4.1 The proposed allocation of the corporate grants programme 2005 / 2006 is outlined in appendix 1. This allocation is founded upon the following principles:
  - Any voluntary and community sector organisation needs to demonstrate its capacity to assist the council in delivering the Community Priorities in 2005 / 2006;
  - Any organisation receiving funding has been subject to an assessment by both written application and external visit;
  - Organisations fulfilling health and social care and educational priorities will be considered for funding support through education and social services departments; and
  - No single organisation will receive more than £150,000 support in 2005 / 2006.

# Investment in Voluntary Sector Development, Capacity Building and Partnership Working in Social Services

- 1.1 There are substantial new and evolving ways in which the Council now invests in the voluntary sector, in addition to the corporate grants programme. These are focussed on supporting the voluntary sector, as national and local partners to meet local and national priorities.
- 1.2 Capacity and relationship building. The following are examples of where the Council and Social Services has built and continues to engage pro-actively with the voluntary sector
  - CVS service level discussions about how to achieve a better local compact
  - LSP health and social care sub-group
  - CSSB CVS and other specialist children's groups active engagement on project and resource development
  - Special event in April for introducing new team to be followed up by regular forums.
- 1.3 Partnership development. The following are examples of work in progress;
  - User Carer Forums relaunched
  - Using the Voice of the Voluntary Sector as representatives of service users and carers and using Voluntary Sector to conduct user surveys e.g. HUB. Carers Association – model of new ways of working to deliver priorities together and meet national targets for local people.
  - Partnership event taking place in April jointly with the voluntary sector to introduce the new Social Services Departmental team and lay out our future Commissioning and Contracting intentions and direction.
- 1.4 Contracts and Service Legal Agreements replacing previous grant regime.

Social Services invested £96,700 in the voluntary sector in grants only for 2004 / 2005. These were the former 'corporate grants' deemed to be in Social Services. There have been no overall cuts but a hugely significant increase in voluntary sector funding through contracting. Our estimated spend for 2004 / 2005 is now £8.3 million. This has risen year on year from £6.7million, a 23.8% increase from 2002 / 2003 to 2004 / 2005.

- 1.5 More work underway on:
  - Clarifying commissioning intentions annually with the Voluntary Sector.
  - Relaxing tight procurement approaches so that partnerships with Voluntary Sector can be built alongside tendering process.
- 1.6 Needs based allocations

Social Services now undertake a thorough needs based assessment both for grant aiding and for the more substantial contracting process.

The Heads of Service and Commissioning managers are fully engaged in this process, linking into service priorities.
