### 1 Introduction

## 3 Legal Implications

3.1 S.31 of the Local Government Act 1985 makes provision for the replacement of members to a joint authority such as ELWA. Under the Act, a constituent council may at any time terminate the appointment of a person appointed by it to a joint authority and appoint another member of the council in his/her place. Where a constituent council exercises its powers of replacement it must give notice of the new appointment and of the termination of the previous appointment to the authority to which those appointments were made.

3.2 The London Boroughs of Barking & Dagenham, Newham and Redbridge have each given notice to ELWA that they have replaced their appointees in the following ways:
