

Background Paper for Report to Cabinet on 15 February 2016 for Adult Social Care Charging Consultation

November 2015 – January 2016

Consultation Process- Charging

Between the 23 November 2015 and 17 January 2016 the Council carried out an exercise to consult residents on proposals to amend its charging policy for those receiving adult social care services and their informal or family carers. The report is being presented to Cabinet on 15 February 2016 reports on this consultation and the recommendations in the report have taken the feedback received from the following into account.

The recommendations proposed in this report are based on the feedback from the following:

- a) Responses received to date from service users and carers the wider community who participated in the consultation.
 - An invitation to participate in the consultation was sent to all service users and their carers (carers included those known to the council and a list provided by Carers of Barking and Dagenham).
 - The One-Borough Newsletter -8th January 2016 invited individuals to have their say on the proposals.
 - Communications also reached the community by extended advising them of the proposal using other forms of social media such as Facebook.
- b) Participants were able to express their views by:
 - Speaking directly to an officer (approx 60 people called the Financial Assessment team in the first three days of the consultation)
 - Completing the online survey (see attached report)
 - Formal written response- 1 received
 - Forming part of a consolidated response – 1 written response received from Carers UK.
- c) Public consultation sessions were held on the 8th December 2015 and 7th January 2016. The first meeting on the 8th December was attended by a very small number of carers (5) however the meeting of the 7th January held at the Civic in the Chambers greater attendance from a much wider representative group of individuals which included carers and carers not known to the

Council, service users with physical and learning disabilities, representatives from the voluntary sector and care and support worker supporting their clients.

Approximately 30 people attended. Representatives from the Financial Assessment Team and an ASC Service Unit manager were present.

d) The following forums/ meetings were attended:

- Healthwatch- 1st December 2015- 7 attendees
- Health and Wellbeing Board- 8th December 2015

- CSV Equalities Forum- 14th December 2015-approx 9 attendee (this excludes Council officers)
- Learning Disability Partnership Group- 15th December 2015



Do you think the Council should recover DFGs where it can do so?





The DFGs are specifically for those who identify as disabled and need to make changes to their home (such as widening doors, installing ramps and improving access to rooms with stairlifts etc). If someone leaves their home for longer than five years then it is perfectly fair and within the boundaries of the DFG eligibility criteria to begin recovering the grant. Therefore it is unquestionably fair to begin recovering the grant after the Council's proposed 10 year period - although I would suggest amending the period to 5 years.</p>



Do you agree that we should change our set disregards to £5, £15 or £25 per week?





Do you agree that the Council should make these changes for existing service users gradually each year?





Do you agree it is fair to charge carers for care and support services?







What is your gender?



Do you identify, or have you ever identified as Transgender?



What is your ethnic group?







Do you consider yourself disabled?



Please specify your disability





What is your religion?


