Minutes

1. Introductions and Apologies for Absence

The chair welcomed the board and introductions and apologies were noted. The board welcomed Sangeeta Bhuhi as the new MOPAC link officer and April Bald as the new Operational Director for Childrens' Care and Support. The chair highlighted the board is an open public meeting however the second half of the board will be a private session for workshops and shared learning.

2. Declarations of Interest

No declarations of interest.

3. Minutes and Action Log

Minutes from July's CSP board were review by members highlighted changes to be made. Comments were provided electronically via members who were not in attendance, these changes have been made. The action log was reviewed, and the following were added.

4. Stop and Search Update

Inspector John Goodwin updated members on the Section 60 that was put in place on Wednesday 19 September 2018. Steve Thompson raised concerns as to whether there is the correct level of resource to be able to deliver the section 60 for a large focus area. The Section 60 covered from Dagenham Heathway through to Romford Town Centre. It is vital that we ensure there is enough resource to implement and deliver the Section 60 to ensure we don't lose community confidence.

ACTION: Fiona Taylor to contact Neil Matthews to request report on Stop and Search. (Complete)

ACTION: Neil Matthews to circulate a briefing to CSP members on Stop and Search within the borough. (Complete)

5. Information Sharing Agreements

Fiona Taylor highlighted that ISA's have been requested and those submitted are not fit for purpose, following requests B&D will commission an overarching ISA to cover the CSP. On behalf of Rita Chadha, Fiona Taylor highlighted the importance of the ISA given the

opportunities for joint funding applications on serious youth violence. All members approved an overarching ISA is the best way to take this forward.

ACTION: Fiona Taylor to commission overarching ISA for the CSP. (In Progress)

6. Community Safety Plan

Jade Hodgson updated members on the development of the Community Safety Plan. Continuous work is being done to ensure that the plan aligns with other strategies developed through partnership boards. The plan is being aligned with the Joint Health and Wellbeing Strategy and the Violence Against Women and Girls Strategy to highlight shared priorities and to ensure the language is consistent. Work is also being done to ensure the plan links with the mayoral priorities. Jade Hodgson highlighted that the sign off timescale has altered and will be presented to Corporate Strategy Group (CSG – the Councils Chief Officer Group) in November and Cabinet in December 2018. Members noted the following;

- Children and Young People priority group could include wider information around contextual safeguarding.
- A stronger focus is on required on CSP priorities.
- Align with other strategic proposals i.e. Prevent and ComSol.

Jonathon Toy outlined that the document reflects priorities on both a regional and local level and focuses on two main areas round Criminal Justice and Transition and Trauma. The plan outlines cross cutting themes, Fire Safety, Perception of Safety and Persistent Offenders as well as emerging trends.

Jonathon Toy and Jade Hodgson welcomed further comments from CSP members on the development of the Community Safety Plan.

ACTION: Jade Hodgson to send updated plan to CSP members for review and comments. (Complete)

ACTION: April Bald/ Angie Fuller to update the CYP priority slide to include contextual safeguarding. (Complete)

ACTION: All subgroup leads to review priority slides to ensure all areas and reference to strategies are included.

ACTION: All members to review Community Safety Plan and send comments to Jade Hodgson.

Members of the board highlighted the direct impact the BCU has had on MPS representation for boards and subgroup meetings. It was highlighted that this has been seen across all strategic board structures. The board recognised the difficulty within police structures however members emphasised the need for a consistent representative at the correct seniority to update and take matters forward.

ACTION: Fiona Taylor to liaise with MPS to discuss having a continuous representative at boards and subgroups at the correct seniority. (Complete)

7. Violence against Women and Girls (VAWG) Strategy

Sonia Drozd updated members on the development of VAWG Strategy on behalf of Hazel North-Stephens. It was noted that the strategy is in the final stages of development and has been taken to the board to ensure all members have had sight of the document. The strategy has been developed through consultation forums, VAWG subgroup, service users and survivors' feedback. CSG have approved the strategy and next stage is to go to Health and Wellbeing Board in November 2018. The following feedback was noted;

- Needs a wider conversation around commissioning arrangements, a commissioning group was favoured to combine all elements linked to the VAWG strategy. A plan is being pulled together to identify how we should commission services going forward.
- Development of a pathway, similar to the Hoarding Pathway, would be useful to ensure people can identify the correct route and what options are available throughout the commissioning process.
- As this is a public facing document the language needs to be reviewed to ensure both residents and professionals understand what is being put forward, for example using terminology such as Trauma Informed
- MOPAC highlighted that the commissioning will need to consider the PAN London changes to DV services.
- The CVS questioned the continued use of the word resilience.
- Could the strategy include the issue of domestic violence and no recourse to public funds either through the strategy or the action plan?
- The strategy could also be strengthened by structural inequality as opposed to fairness, cohesion and diversity.
- CVS would welcome the acknowledgment on changes to the social care workforce post Brexit.
- Will the council consider include the 10 day paid offer for domestic violence survivors proposed by the Labour Party?
- The CVS applauded the commitment to lived experience.

ACTION: Hazel North-Stephens to review language within the strategy to ensure that both residents and professionals can understand what is being presented. (Complete) ACTION: CSP members to send any comments/ feedback on the plan to Sonia Drozd. (Complete)

ACTION: Sonia Drozd/Hazel North-Stephens to move forward with commissioning group for DV services. (Complete)

ACTION: Hazel North-Stephens to report back to Rita Chadha regarding the inclusion of the no recourse to public funds and the 10 day paid offer for DV. (Complete)

8. Update on DVHR Investigations

Fiona Taylor updated members of the board on the DHR process and open investigations. The chair highlighted that the process of identifying the membership will be agreed to ensure once a decision is made we can move forward in a timely manner. The requirements are for the CSP to agree an Independent chair, MOPAC are supporting with liaising with other boroughs to pull together a directory on independent chairs and experience of working with the chairs. MOPAC role will be to connect boroughs rather than offering recommendations. The CSP chair will write to members regarding any recommendation of an Independent chair at the appropriate time.

There is no further information available on the current cases to date however members will be kept informed once further information is available.

9. Workshops

A number of CSP members delivered 4 presentations, these sessions were held to address a range of Community Safety priorities and shared priorities across partnership boards.

9a. Joint Health and Wellbeing Strategy

Matthew Cole and Florence Henry updated CSP members on the development of the Joint Health and Wellbeing Strategy. The strategies visions are to improve the health and wellbeing of residents and reduce inequalities at every stage of people's lives by 2023. The refreshed strategy focuses on three themes, best start in life, early diagnosis and building

resilience, these areas of focus have been identified by Health and Wellbeing Board as the areas that will have the biggest impact on resident's lives.

The strategy sets out the six outcomes which we aim to achieve in Barking and Dagenham. Four of these outcomes relate to resilience and focusing on Adverse Childhood Experiences, education and skills and employment, physical and mental wellbeing and ageing well. The proposed outcomes of what we aim to achieve in Barking and Dagenham and the increased need for building social capital and structural factors are shared across strategic boards highlighting the need for strong joined up working. Members noted that the outcomes focus around Improving Access to Psychological Therapies (IAPT) need to include how aces and experiences are having an effect on children within families. Across partners and organisations, we are realising the need for a different approach and now is as good a time as any to drive these changes.

Members of the board highlighted the increasing need for further focus on lower level emotional support to support ACE's and mental health services within schools. Steve Norman put forward the potential of using the Safe Drive, Stay Alive concept and tailoring this in terms of health as a way on creating significant impact.

The Strategy has been aligned with partnership plans and strategies to ensure it highlights shared priorities and where there is requirement for partnership working. It was noted that the strategy will be going to public consultation in November and presented to the HWBB in February 2019 with commissioning intentions for April/July 2019.

ACTION: Matthew Cole to circulate the full School Survey report CSP members. (Complete)

9b. Trauma Informed Model

Jade Hodgson presented the Trauma Informed Health Intervention, the model is a trauma informed response to youth violence designed to support children and young people (CYP) at an earlier age who are at risk of becoming involved in violence and crime. There is a body of evidence that support indicators of behavioural issues for children and young people from school years 5 and 6 therefore we have focused on delivering the model for this cohort.

The model has been developed collaboratively with local schools, voluntary organisations and community organisations to design a programme that can be implemented through local schools as a form of preventative work. The programme has been heavily based on the understanding of Aces and the impacts that this has on later life, this foundation links into the Joint Health and Wellbeing Strategy outcomes around Adverse Childhood Experiences.

The board opened discussion on how organisations and partners can support the delivery of trauma informed care. The following was discussed;

- LBBD substance misuse service have recommissioned services to become trauma
 informed supporting the targeted intervention tier within the trauma informed health
 intervention model. The service has adapted a trauma response to counselling
 provisions for both adult and childrens services which include a clinical psychologist.
 Involving family members within the services will support the development of social
 capital within the joint health and wellbeing strategy.
- Angie Fuller advised that the YOS have commissioned a senior parenting worker to undertake the RockPool ACE's programme training. The board need to identify how we can we bring current provision and new work together.
- Steve Norman highlighted the need for further preventative work before primary schools and school preparedness identifying family environment pressures around the young person/child. The Safeguarding Adults Board (SAB) have a priority of

childhood neglect which links to the best start in life for the Joint Health and Wellbeing Strategy.

9c. Fire Safety

Steve Norman delivered a workshop on fire safety and prevention to highlight the importance of a partnership approach and best practice for fire safety. The workshop aimed to identified how to collectively recognise the risks across agencies to support the London Fire Service in delivering effective services. An updated on current structures and an interim cover for future boards was provided. Lee Walker has been assigned as an interim replacement for Steve Norman. All correspondence should be sent to Lee Walker and copy in Steve Norman.

An update was provided on the dwelling fire in Barking and Dagenham on Tuesday 25th September. The fire caused damage to two houses, it was identified that the partitioning of the house was what caused the fire to spread into the second home. Steve Norman highlighted that no one was hurt as a result of the fire.

Grenfell inquiry is currently on phase 1 reviewing everything that happened on the night of the incident, phase 2 will start in new year reviewing what led up to the night. There have been a number of buildings identified with cladding including private sector buildings that do not meet regulations. There has been a focus on blocks of flats above 8 meters.

How do we identify the risk?

Fire safety in the home training packages have been delivered, the London Fire Service would like to deliver this free training to all council workers and workers contracted to the local authority to increase the opportunity of identifying fire risks. A free online training package on Fire Safety in the Home for all who have contact with vulnerable people or who manage people who have contact with vulnerable people. This was developed in partnership with London Fire Brigade and the TSA. All CSP partners should encourage their staff to carry out the training. The link is https://www.tsa-voice.org.uk/fire-safety-in-the-home.

There is an appetite to conduct further work looking at fly tipping, identifying inadequate doors/frames, hoarding etc. The chair highlighted work is being done within the council to address areas such as fly tipping across Enforcement and Public Realm Services.

The London Fire Service don't have much involvement with police estates meetings or MPS representatives at fire safety groups. Members agreed a representative from LFB should be in attendance to ensure joined up working and information sharing across correct agencies.

ACTION: Steve Norman to send John Goodwin information for the Fire Safety group to arrange for an MPS representative to attend. (Complete)

ACTION: Steve Norman to send Fiona Taylor details of LFB home training package to circulate to board members. (Complete)

ACTION: Fiona Taylor to circulate LFB Fire safety in the home training packages to CSP members, work with April Bald to identify Key professionals to uptake training offer.

ACTION: Jade Hodgson to provide contacts for boroughs dementia lead to Steve Norman. (Complete)

1. Introduction

1.1 This report provides an overview of offences committed by young people from Barking and Dagenham and the demographic breakdown of the young people involved. Data has been taken from the supplementary tables of the annual youth justice statistics. The latest annual release covers the 2016/17 period. Comparison with regional and national figures are provided. Updates for the 2017/18 period should be available in late January 2019.

2. Key Observations

Demographics

- 2.1 There were 222 Children and Young People (CYP) from Barking and Dagenham who received a caution or conviction in 2016/17.
- 2.2 Although this is an increase on the year before overall levels have decreased over time and are 34% lower than 2010/11.
- 2.3 In comparison both England and Wales and London have seen year on year decreases since 2010/11 with a 57% decrease and a 44% decrease respectively at the year ending March 2017. This indicates that the rate of Barking and Dagenham's decrease in the number of young people receiving a caution or conviction is slower than regional and national averages.
- 2.4 In 2017-18, 15 to 17 year olds made up 70% of the offending population despite accounting for only 34% of the total 10 to 17 year old target population within the borough.

- 2.5 15 to 17 year olds are therefore overrepresented within the offending data compared to the local population estimates. This is a common theme seen across both regional and national figures.
- 2.6 The levels of BAME offending are proportionate to the make-up of the borough. In comparison both London and England and Wales had an over representation of BAME receiving a caution or conviction in 2016/17.
- 2.7 Males continue to make up the majority of young people receiving a caution or conviction in the borough in 2016/17, a theme consistent with London and England and Wales figures.
- 2.8 Between 2010-11 and 2016-17 the number of 15 to 17 year olds from Barking and Dagenham who received a caution or conviction has decreased (-43%) in comparison to the number of 10 to 14 year olds which saw a 3% increase. From 2014/15 to 2015/16 there was an increase in both the number 10 to14 year olds and 15 to 17 year olds receiving a caution or conviction in Barking and Dagenham, but the 10-14 year olds have continued to increase into 2016/17 whereas the 15 to 17 year have declined. This does not follow regional and national trends which have both seen year on year decreases across both age groups.

Offences:

- 2.9 The 222 CYP from Barking and Dagenham committed 670 proven offences in 2016/17. Although this is lower than a recent peak in 2010-11 of 776 offences there has been year on year increases in the number of offences by Barking and Dagenham CYP from 2014/15 to 2016/17. Barking and Dagenham doesn't follow the regional and national trends for the same periods to 2016/17 which has seen year on year decreases in the number of proven offences by CYP.
- 2.10 In Barking and Dagenham since 2010/11 to 2016/17 there has been an increase in half of all the offences groups with the largest increases seen in Violence Against the Person offences, unauthorised vehicle taking and sexual offences. In comparison across the same period there has been a decrease in all offence groups across both England and Wales and London with the exception of unauthorised vehicle taking in London by CYP which has seen a 24% increase.
- 2.11 The top five offences committed by CYP in Barking and Dagenham in 2016/17 by volume was: Violence Against the Person, Theft and Handling, Drugs, Criminal Damage, Robbery. This is consistent with previous years.

3. Recommendations



4. Demographics of children and young people offending

4.1 For Barking and Dagenham in the year ending March 2017:

- There were 222 young people who received a caution or conviction, a fall of 116 young people (-34.3%) compared to -22.1% across London and -51.6% across England and Wales.
- When compared to the previous year there was a fall of 22 young people (-9.1%) from Barking and Dagenham. Across London there was a fall of 3.1% and across England and Wales there was a fall of 6.2%.

Figure 4.1: Number of individual children and young people given a caution or conviction, Barking and Dagenham, years ending March 2007 to March 2017



4.2 In Barking and Dagenham there were year on year falls between 2010/11 to 2014/15. An increase was seen in 2015/16 before decreasing again within 2016/17. At the end of 2016/17 levels were 34% lower than 2010/11. In comparison both England and Wales and London have seen year on year decreases since 2010/11 with a 57% decrease and a 44% decrease respectively at the year ending March 2017.




Figure 4.2: Demographic characteristics of children and young people receiving a caution or conviction compared to the general 10 – 17 population, Barking and Dagenham, year ending March 2017.



^{*}For age and gender, population is based on 2017 mid-year estimates. For ethnicity, population is based on the 2011 census. The ethnic breakdown of the population will likely have changed from 2011, so these figures should be treated as an estimate.

- 4.3 Figure 4.2 shows that while 15 -17 years olds make up 34% of the 10 17 year old population in Barking and Dagenham, in the year ending March 2017 they made up 70% of children and young people who received a caution or conviction.
- 4.4 Males made up 52% of the general 10 17 population but accounted for 87% of the total number of children and young people who received a caution or conviction.

- 4.5 Overall both the number of BAME and White children and young people who received a caution or conviction have decreased year on year since the year ending March 2012. The rate of decline is equal between White and BAME. In comparison London and England and Wales averages have both seen the number who were white reduced at a much higher rate. This has led to an increase in the proportion of BAME children and young people receiving a caution or conviction.
 - England and Wales: from 18% in the year ending March 2012 to 25% in the latest year.






Figure 4.4: Number and proportion of children and young people receiving a caution or conviction by gender, Barking and Dagenham, years ending March 2012 to March 2017




- 4.6 In the year ending March 2017, there were around 28 young females and around 194 young males who received a caution or conviction. Between March 2012 and March 2017 there was a 3% increase in the number of 10–14 year olds who received a caution or conviction compared to a 43% decrease in the number of 15 to 17 year olds.
- 4.10 When compared to the previous year (March 2016) there was a 3% increase in the number of 10-14 year olds compared to a 13% decrease in the number of 15 to 17 year olds receiving a caution or conviction from Barking and Dagenham.
- 4.11 In comparison both age groups across England and Wales have seen similar decreases compared with the year ending March 2012 (55% (10 to 14yr) and 58%(15 to 17yr) respectively and the year ending March 2016 (both 14%).



- 5.2 For Barking and Dagenham in the year ending March 2017:



- 5.3 Following a downward trend between 2011-12 and 2013-14 offences stabilised in 2014-15 before increasing again from 2015-16 onwards. This is a 9.4% fall from 670 proven offences 7 years ago (2010-11) and a 1.2% increase compared with the previous year.



Numbers

- 6.1 The data shows for Barking and Dagenham there has been an increase in the number of proven offences in half of the offence groups since 2010/11. The offence groups to see the largest increase in offences by volume are in:
 - Violence Against the Person proven offences from 150 in 2010/11 to 178 in 2016/17. Violence Against the Person offences has seen a sharp increase in 2015/16 and continues to increase in 2016/17 following years of decline,
 - Vehicle theft / unauthorised taking which has seen increased from 13 offences in 2010/11 to 40 in 2016/17.
 - Sexual offences which have increased from 1 in 2010/11 to 26 in 2016/17.






Figure 5.5: Percentage point change in the proportion of proven offences by children and young people, Barking and Dagenham, between the year ending March 2011 and March 2017



1. Introduction

1.1 This report provides an overview of offences committed by young people from Barking and Dagenham and the demographic breakdown of the young people involved. Data has been taken from the supplementary tables of the annual youth justice statistics. The latest annual release covers the 2016/17 period. Comparison with regional and national figures are provided. Updates for the 2017/18 period should be available in late January 2019.

2. Key Observations

Demographics

- 2.1 There were 222 Children and Young People (CYP) from Barking and Dagenham who received a caution or conviction in 2016/17.
- 2.2 Although this is an increase on the year before overall levels have decreased over time and are 34% lower than 2010/11.
- 2.3 In comparison both England and Wales and London have seen year on year decreases since 2010/11 with a 57% decrease and a 44% decrease respectively at the year ending March 2017. This indicates that the rate of Barking and Dagenham's decrease in the number of young people receiving a caution or conviction is slower than regional and national averages.
- 2.4 In 2017-18, 15 to 17 year olds made up 70% of the offending population despite accounting for only 34% of the total 10 to 17 year old target population within the borough.

- 2.5 15 to 17 year olds are therefore overrepresented within the offending data compared to the local population estimates. This is a common theme seen across both regional and national figures.
- 2.6 The levels of BAME offending are proportionate to the make-up of the borough. In comparison both London and England and Wales had an over representation of BAME receiving a caution or conviction in 2016/17.
- 2.7 Males continue to make up the majority of young people receiving a caution or conviction in the borough in 2016/17, a theme consistent with London and England and Wales figures.
- 2.8 Between 2010-11 and 2016-17 the number of 15 to 17 year olds from Barking and Dagenham who received a caution or conviction has decreased (-43%) in comparison to the number of 10 to 14 year olds which saw a 3% increase. From 2014/15 to 2015/16 there was an increase in both the number 10 to14 year olds and 15 to 17 year olds receiving a caution or conviction in Barking and Dagenham, but the 10-14 year olds have continued to increase into 2016/17 whereas the 15 to 17 year have declined. This does not follow regional and national trends which have both seen year on year decreases across both age groups.

Offences:

- 2.9 The 222 CYP from Barking and Dagenham committed 670 proven offences in 2016/17. Although this is lower than a recent peak in 2010-11 of 776 offences there has been year on year increases in the number of offences by Barking and Dagenham CYP from 2014/15 to 2016/17. Barking and Dagenham doesn't follow the regional and national trends for the same periods to 2016/17 which has seen year on year decreases in the number of proven offences by CYP.
- 2.10 In Barking and Dagenham since 2010/11 to 2016/17 there has been an increase in half of all the offences groups with the largest increases seen in Violence Against the Person offences, unauthorised vehicle taking and sexual offences. In comparison across the same period there has been a decrease in all offence groups across both England and Wales and London with the exception of unauthorised vehicle taking in London by CYP which has seen a 24% increase.
- 2.11 The top five offences committed by CYP in Barking and Dagenham in 2016/17 by volume was: Violence Against the Person, Theft and Handling, Drugs, Criminal Damage, Robbery. This is consistent with previous years.

3. Recommendations

It is recommended that the Community Safety Partnership Board:



4. Demographics of children and young people offending

4.1 For Barking and Dagenham in the year ending March 2017:

- There were 222 young people who received a caution or conviction, a fall of 116 young people (-34.3%) compared to -22.1% across London and -51.6% across England and Wales.
- When compared to the previous year there was a fall of 22 young people (-9.1%) from Barking and Dagenham. Across London there was a fall of 3.1% and across England and Wales there was a fall of 6.2%.

4.2 In Barking and Dagenham there were year on year falls between 2010/11 to 2014/15. An increase was seen in 2015/16 before decreasing again within 2016/17. At the end of 2016/17 levels were 34% lower than 2010/11. In comparison both England and Wales and London have seen year on year decreases since 2010/11 with a 57% decrease and a 44% decrease respectively at the year ending March 2017.




Figure 4.2: Demographic characteristics of children and young people receiving a caution or conviction compared to the general 10 – 17 population, Barking and Dagenham, year ending March 2017.



- 4.4 Males made up 52% of the general 10 17 population but accounted for 87% of the total number of children and young people who received a caution or conviction.

- 4.5 Overall both the number of BAME and White children and young people who received a caution or conviction have decreased year on year since the year ending March 2012. The rate of decline is equal between White and BAME. In comparison London and England and Wales averages have both seen the number who were white reduced at a much higher rate. This has led to an increase in the proportion of BAME children and young people receiving a caution or conviction.
 - England and Wales: from 18% in the year ending March 2012 to 25% in the latest year.
 - London: 57% in the year ending March 2012 to 61% in the latest year.






Figure 4.4: Number and proportion of children and young people receiving a caution or conviction by gender, Barking and Dagenham, years ending March 2012 to March 2017













Figure 5.5: Percentage point change in the proportion of proven offences by children and young people, Barking and Dagenham, between the year ending March 2011 and March 2017







What are we doing to drive improvement going forward?

- Daily review of all new burglary reports to quality assure initial investigation, identify linked series
 early and safeguard against risks where identified
- Regular tasking meetings and cross-border conference calls chaired by Detective Chief Inspector.
- Ongoing tasking of Met Intel analytical and FIO assets to develop intelligence into known offenders.
- Targeted media releases highlighting 'good news' and crime prevention/target hardening via local news and MPS social media
- Weekly review of hotspots and key targets to identify default patrol areas for uniformed and plain-clothes patrols
- Ongoing review of investigative processes to ensure early capture of best evidence.

Examples Of Good Work – Operation Mexico

- OCN of 20+ nominals identified in vast series of Millennium Burglaries across NE and South London, Essex,
 Herts and Kent responsible for believed over 200+ offences, including a significant amount across Havering,
 between December 2017 and February 2018.
- Following an extensive and complex investigation, 5 males have been convicted of their involvement in these offences receiving between 3.5 and 4.5 years each in custody for conspiracy to commit burglary and conspiracy to steal motor vehicles. Their arrests led to a significant reduction in offences being experienced in Havering and surrounding boroughs, which has been maintained ever since they were taken off the street.
- A further 7 offenders have recently been charged for their part in this large conspiracy and are due to appear at Snaresbrook Crown Court on the 19th December 2018.

Examples Of Good Work – Charlie Davies

- A large scale linked series of residential and non-residential burglaries across all of East Area and surrounding was identified by Priority Crime Officers where the lone male suspect, habitually wearing a hi-vis jacket, was committing opportunistic offences breaking in and stealing from within. It is believed over 30 offences over a course of within EA alone were committed by DAVIES.
- Exensive forensic submissions and CCTV work identified the suspect as Charlie DAVIES, of no fixed abode, but with strong links to the Dagenham area.
- PCT officers led a manhunt-style approach and DAVIES was eventually located and arrested in Basildon, Essex.
- Due to the high quality investigation and extensive evidence, DAVIES was successfully charged and remanded with 16 burglary offences, awaiting trial. Further linked offences continue to be identified through ongoing forensic work and the investigation to obtain charges for these continue.

Examples of Good Work – Steleo Ramadani

- Known Dagenham burglar, moped crime nominal and gang affiliate Steleo Ramadani was arrested on 10/10/2018 in relation to multiple burglaries across East Area and Kent following work by Priority Crime Team and the Violent Crime Task Force.
- Following joint work between the PCT and Kent Police, he was charged with 8 burglary offences (MPS and Kent) and is on remand at HMP Cookham Wood awaiting trial.
