MEMBERS ALLOWANCES 2003/2004

FOR DECISION

This report sets out the recommendations of the Independent Review Panel into Members Allowances.

<u>Summary</u>

As part of this year's review a survey of Special Responsibility Allowances has been undertaken resulting in a number of changes and also some increases. This follows a members' annual survey and report concerning their activities, responsibilities and time input in order to carry out their duties as Councillors. The increase is based on a changed formula agreed by the panel.

In addition Basic Allowances have been increased by 2.9% for all members. Details of the revised scheme are as shown in the attached schedule (Appendix A) which is effective from15 May 2003. In addition the Panel have reiterated that each member complete a mandatory annual report. Members are reminded of the need to keep records as an aid to completing these at the end of the calendar year.

Members Allowances will be reviewed again next year and any proposals will be reported to the Executive.

Recommendation/Reason

The Executive is asked to recommend the Assembly to agree allowances and the scheme for 2003/04, as set out in Appendix A, with effect from 15 May 2003, in accordance with the recommendations of the Independent Review Panel.

1. <u>Background</u>

1.1 In 2000 an Independent Review panel was appointed to review Members allowances. The panel undertook a comprehensive review, which took into account many factors including the legal framework, the Council's existing scheme of payments, other London Boroughs schemes, time inputs and special responsibilities as well as interviewing a number of Members to seek their views on how they perceived their "job". The panel produced Job profiles as a result before publishing their recommendations, which were then adopted by the Assembly.

- 1.2 Subsequently, 2001 saw the mandatory introduction of independent panels through legislation and the existing panel reappointed here. Members Allowances were increased in 2001, and again in 2002 (but only in respect of basic allowances) as a result of the information obtained from Members via a survey. This being based on a formula that uses the average increase in earnings in the borough, as recommended by the panel.
- 1.3 The results of the survey in respect of different bandings for Special Responsibility Allowances (SRA) were not conclusive and the panel felt that a further detailed study should be undertaken specifically relating to the different bandings as part of the review for 2003.
- 1.4 In addition the panel also recommended that an annual report from each Member be completed in line with the proposal of May 2000. It was further agreed that this be mandatory for all Members commencing with the period 1 January 2002 to 31 December 2002.

2. <u>Review for 2003</u>

- 2.1 The panel felt it would be useful to incorporate a remuneration survey as part of the annual report, as such a combined members' annual report and remuneration survey was compiled and sent to all members in December 2002. Subsequently all members made a return.
- 2.2 In order to have a clear understanding of the results of the report/survey, the panel invited various members in different bandings, to meetings to go through their returns, ask questions and generally seek their views. The panel also felt that by interviewing members as well as conducting the survey as part of the review that this would establish their position to be able to account for the decisions they make. In particular to the community and of course to feedback to the members themselves as part of the review process.
- 2.3 Time was also spent in looking at other activities such as Chair of Community Forums to see if there was a need to increase the number SRA allowances. Overall the view of the panel, having consulted members, was that there was not a need to consider this for 2003/04, although this may need to be revisited in the future.
- 2.4 It was also noted from members' returns that SRAs' bandings should not be calculated by reference to hours alone. Indeed the panel agreed with the consensus of opinion that a multiple of the basic allowance would be an equitable way to reward responsibility, although hours will continue to be monitored, to ensure a level of consistency with the different bands.
- 2.5 Consideration was also given to reviewing the allowances on the basis of population and comparison in this area to neighbouring boroughs. However, the composition of Barking and Dagenham and its neighbouring boroughs varies in many ways, both socially and economically and as such the panel did not feel this would be a fair way to consider allowances against those paid elsewhere.

2.6 It was also felt by the panel that to continue to use surveys based on the average weekly pay for Barking and Dagenham, are not always accurate, as these have been based on small sample numbers. As a result the panel propose that from this year's increase onwards that they be based on the Bank of England Retail Price Indices as at December in the year prior to the increase, in this case December 2002.

3. <u>Conclusions</u>

- 3.1 The returns showed that overall there had not been any real increase in basic hours undertaken by 'back bench' members. This was as expected as the hours were only changed last year as part of the review of the basic allowance. However, there had been significant increases in hours SRA's for posts in Bands 1, and 2.
- 3.2 It is clear from the returns that there has been an increase in workload and hours for a number Special Responsibility posts since the last review of these allowances in May 2000. This is due to the review being based on estimates of time that would be required as part of the modernisation of the Council. The data collected from almost three years operation has shown that the hours need adjusting as these had been underestimated, which in turn leads to a recalculation. However, as mentioned a change in formula with regard the calculation acknowledges the different levels of responsibilities undertaken in the different bandings and how these have developed over the last few years.

4. <u>Recommendation</u>

- 4.1 As mentioned in 2.4, the panel have recommended a change in formula for SRA's (bands 1 to 3) by multiplying the basic allowance, depending on a post's level of responsibilities. Each post also having a level of hours expected to be undertaken.
 - 4.1.1 **Band 1** (a) Leader of the Council, **from** £17,100 **to** £26,400 120 hours plus per month (£8,800 x 3).
 - (b) Deputy Leader of the Council, from £11,400 to £17,60090 hours plus per month (£8,800 x 2)
 - **Band 2** Members of the Executive and Chair of the Scrutiny Management Board, **from** £8,400 **to** £13,200 90 hours plus per month (£8,800 x 1.5)
 - Band 3Chair of Assembly and Chair of the Development Control Board
from £8,400 to £8,800 75 hours per month (£8,800 x 1)
 - 4.1.2 Band 4 Deputy Chair of Assembly, Deputy Chair of the Scrutiny Management Board and Deputy Chair of the Development Control Board remains at £3,000 Leaders of the Minority Parties, from £3,000, (divided between parties pro-rata to the number of seats), to a minimum of £1,000* each (*£300 per seat with a minimum of £1,000 per Leader). 65 hours per month

- 4.2 The panel have also recommended that the basic allowance be increased, as mentioned, by reference to the Retail Price Indices as at December in the year prior to the increase, in this case December 2002. The increase applicable to the basic allowance would therefore be 2.9% for 2003.
 - 4.2.1 **Band 5** The revised Basic Allowance for 2003/04 is £8,800 (£8,550 x 2.9% = £8,800)
- 4.3 For comparison purposes, the Independent panel's recommendations of payments, together with the ALG's. It should be noted that the ALG recommendations are as at 2001/02, as follows: -

4.4 Child Care and Dependent Carers Allowance

Although no claims have been received to-date the panel recommend that the minimum national hourly rate should apply, currently $\pounds4.20$ ($\pounds4.50$ wef October 2003) and that members be able be evidence the need for payment of the allowance.

4.5 Provision has been made in this year's estimates to meet the increases for 2003/04.

4.6 <u>Pensions for Councillors</u>

The panel also agreed that all Councillors be eligible to join the scheme. Legislation regarding this has just been published. A separate report regarding this matter will therefore follow shortly.

MEMBERS' ALLOWANCES SCHEME

1. <u>Title and Term</u>

The scheme is known as the London Borough of Barking and Dagenham Members' Allowances Scheme. The allowances are reviewed annually and take effect the day after Annual Assembly each year.

2. <u>Meanings</u>

"Councillor" means a Member of the London Borough of Barking and Dagenham Council who is a councillor;

"year" means the period ending the day of the Annual Assembly.

3. <u>Basic Allowance</u>

A basic allowance is paid to each Councillor as specified in the Schedule attached.

4. <u>Special Responsibility Allowances</u>

A special responsibility allowance is additionally paid to Councillors who hold certain responsibilities as specified in the Schedule.

5. <u>Childcare and Dependant Carers Allowance</u>

An allowance paid to those Councillors who incur expenditure for the care of dependant relatives or children whilst undertaking 'Approved Duties'.

6. <u>Travel and Subsistence Allowances</u>

Reimbursement of actual and necessarily incurred expenditure whilst undertaking 'Approved Duties'.

7. <u>Renunciation</u>

A Councillor may by notice in writing given to the Chief Executive, elect to forego any part of his/her entitlement to an allowance under this Scheme.

8. <u>Part-Year Entitlements</u>

If the scheme is amended during the year or a Councillor holds office part way through the year, entitlements to basic and special responsibility allowances will be dealt with on a pro-rata basis.

9. Payments

Payments are made in equal instalments every month.

3. Childcare and Dependant Carers Allowance

This allowance is payable to those Councillors who incur expenditure for the care of dependant relatives or children whilst undertaking "approved duties". The rate payable will be £4.20 per hour until 30th September 2003, and £4.50 per hour from 1st October 2003.

4. <u>Travel & Subsistence Expenses</u>

Reimbursement of travel expenses via public transport will be the actual fare paid. Councillors using their own motor vehicle will be reimbursed at the appropriate rate as shown on the Councillors claim forms for travelling expenses and subsistence costs. Similarly, for reimbursement for subsistence costs in respect of meals. Subsistence costs involving an overnight stay are also as shown on the Councillors claim form.

1. <u>Background</u>

1.1 The Gascoigne Community Centre Committee approached Housing & Health and Gascoigne Ward Members to request permission to fence and gate the car park adjacent to the hall to restrict parking to users of the hall.

- 1.2 The Committee felt there was a need to restrict parking following complaints from members of the Association and all users unable to park their cars, due to use of the car park by local residents.
- 1.3 There is sufficient alternative residents parking provision in the area, including a large car park approximately 100 yards from the hall, which is under utilised.

2. <u>Consultation</u>

2.1 The Community Centre Committee, who are also local residents and represent the Association's membership, local Ward Councillors and Officers of DLES were consulted and have no objection to the request.

3. <u>Conclusion</u>

- 3.1 It is recommended that the control of the car park should be passed to the Gascoigne Community Centre Steering Committee for an initial 12- month period.
- 3.2 The Committee to take responsibility for reporting repairs and maintaining the area in a clean and tidy condition. The Committee to sign a contract agreeing to return the car park into the control of the Director of Housing & Health within 1 month of notification, if so required.
- 3.3 The Committee to erect a gallows gate and locking post to restrict access to the car park and to take responsibility for ensuring access to authorised car park users.
- 3.4 The Committee to take responsibility for maintaining the gate.

1. Background

- 1.1 In June a new Grants Administrative Officer was seconded to the Grants Section. The Application Form, Conditions for Grant Award, and all other documentation, concerned with the Grants process were reviewed by the Corporate Grant Officers Panel. Documentation was discussed at each Grant Officers Meeting until it was felt that the Application Pack addressed all the criteria required for an efficient grants service (Equalities and Diversity, Plain English etc). The pack was then sent to the Local Compact Steering Group for information so that they could discuss it with their various organisations.
- 1.2 The pack was sent to all applicants who applied for a grant in 2002/2003 plus all other groups/organisations requesting one for 2003/2004.

- 1.3 Organisations whose partnership arrangements are due for renewal were sent an Application Pack.
- 1.4 An article was placed in the Citizen and the Dagenham Post in September 2002 advertising that Grant Application packs for the period 2003/2004 were available from 16th September, 2002 for Voluntary Organisations giving details of how the packs could be obtained.
- 1.5 122 requests were received for Grant Applications Pack from Voluntary Organisations and 70 completed Applications were returned by the closing date of 30 November 2002. A letter was sent to Organisations on 15 November reminding them to return their completed applications by the closing date.
- 1.6 Of the 70 applications received, 8 were from groups with Partnership Arrangements, 58 applications were from existing organisations and 4 were from new organisations. The applications received were in excess of the budget available of £1,216.378.22. Information of these groups is contained in Appendix B.

2. <u>Corporate Grant Awarding Process</u>

- 2.1 The initial assessment was undertaken which took into account the grants application form (including supporting documents eg: the organisation's constitution, the structure, Statement of Accounts, Health and Safety Policy and Equal Opportunities Statement). The Grant Officers of the relevant service area then made contact with the applicant and consequently assessed the applications based on the Community Strategy as well as the service and client groups that the organisation was working with.
- 2.2 To ensure fairness and openness, the panel of Grant Officers met to look at each grant application form with a view to collectively agreeing on a final recommended score for the organisations and their various projects.
- 2.3 Following the confirmation of the scores awarded to the organisations, officers then made the final recommendation on the level of grants to be awarded to the organisations based on the points achieved as follows: -

Partnership Grants and Existing Organisations

- Partnership Grants and existing organisations scoring over 40 points (67%) were awarded last year's budget plus where requested up to a 10% increase. It should be noted that a few applicants, particularly partnership organisations who would have been entitled to 3 years funding, put in for a large increase and it was considered by officers that if this was agreed, it would result in a larger number of groups not receiving any grant.
- Partnership and Existing Organisations scoring between 30-40 points will receive a standstill budget.
- Partnership and Existing Organisations scoring below 30 points but above 13 points will be given a one off grant. If their performance does not improve, no further grants will be given.

- With regard to new organisations, it was considered that there should be a maximum limit of £10,000 and they should be offered a percentage of £10,000 based on the number of points scored provided it was 30 or above. Organisations were given a notional start up grant of £2000 to encourage them to build up their capacity to be self sufficient.
- Small groups scoring 30 or more points were recommended for full grant. Those below this level, a one off payment of £100.
- £5,000 was set aside for Talented and Gifted Young People.
- 9 applications were recommended to receive no grant at all.
- The Translation and Information Service contract with the Council is for £30,000 per year to provide information translation service to council departments.
- The net result of this for the financial year 2003/2004 is a recommended award of £844,804.02 against a budget of £867,879.00.

3. <u>Financial Changes</u>

As a result of recent changes in Central Government financial grants to the Borough, major service departments including Social Services and Education, Arts and Libraries will have to now include an element of the grants budget within their estimates. This results in the need to make some difficult choices eg: service departments either funding certain voluntary groups or other critical elements of their service. It is suggested that for this year only the recommendations for funding be carried out as set out in Appendix A.

In the future, it is suggested that grants process is changed on the basis of community priorities such as Health & Social Care, Equalities, Education and Learning, Regeneration, Rights and Responsibilities, Cleaner, Greener, Safer with each having an agreed budget and criteria managed via the Community Strategy/Borough Partnership Sub Group. A further report will be made on this subject. Consultation is needed with the Voluntary Sector and this will be undertaken with the assistance of the Director of CVS. This will allow voluntary groups to start seeking alternative funding from other sources over the next 12 months.

4. <u>Monitoring of Grant Awards</u>

Meanwhile, the Corporate Grant Officers are continuing with the monitoring of grants awarded to projects and organisations in the 2002/2003 financial year. Also, the partnership arrangements for 8 Voluntary Sector Organisations are currently under review; these are Council for Voluntary Services, Racial Equality Council, Victim Support, Citizens Advice Bureau, Thameside Community Support, Pre School Learning Alliance, Bereavement Service and Disablement Association.

1. <u>Background</u>

1.1 Currently RSLs are selected on an ad hoc basis for individual sites, often following competitions. This process is time consuming and does not lend itself to a comprehensive approach to future development, which is particularly relevant for Barking & Dagenham given the scale and range of the forthcoming new affordable housing programme.

1.2 The Council had previously selected Hanover Housing Association as the RSL partner to develop extra care housing for elderly people and Look Ahead Housing & Care for supported hostel accommodation, following competition processes.

2. <u>Benefits to be gained from a Panel of Preferred RSL Partners</u>

- 2.1 There is a need to build strong partnering relations with RSLs to ensure the efficient delivery of high quality innovative affordable housing projects to meet the community's needs.
- 2.2 A panel of RSLs will mean there can be better planning for future project delivery with greater certainty for the Council and the RSLs.
- 2.3 This approach will help drive up standards of both development delivery and estate management services of RSLs.
- 2.4 A further and significant advantage which will be derived from the panel is that innovative approaches to funding and resourcing schemes are more likely to be achieved as a result of the certainty and better lead in time for the RSLs working with the Council.

3. <u>Selection Process</u>

- 3.1 Following shortlisting of RSLs that had either worked with the Council or those that had carried out developments within East London; 9 organisations were interviewed by a panel of Members, a tenants' representative and officers, with an observer from the Housing Corporation.
- 3.2 The RSLs were evaluated against a matrix of factors. These were:-
 - Development capacity
 - Tenancy and estate management
 - Regeneration
 - Supported accommodation
 - Black and minority ethnic
 - Demonstration of partnership working with Barking & Dagenham.

4. Proposal

4.1 It is proposed that the following RSLs be selected to comprise the initial panel:-

Anglia (Stort Valley Housing Association), East Thames, Metropolitan and Ujima.

These would join Hanover and Look Ahead, the specialist providers as indicated in para. 1.2.

4.2 Further enquiries be made of London & Quadrant and Presentation to assess if they can satisfy the criteria and therefore also join the panel.

- 4.3 A protocol is being finalised which our RSL partners will be expected to sign. This will set performance standards, for example in the area of estate and tenancy management, against which the RSL partners will be measured. There will be an annual review process and in the event that any RSL fails to perform at the required level action will be considered to either suspend or deselect from the preferred partner panel. The annual review process will also give the opportunity for other RSLs to be considered for addition to the panel.
- 4.4 It is evident that the selected RSLs have differing strengths, therefore, it is proposed to deploy them accordingly to the development and regeneration schemes in the pipeline.
