








### 3. Number of premises opinion?

From your own personal knowledge of the number of gambling premises and gambling machines available to play within Barking and Dagenham, do you consider that there is;











Would you support a local gambling licensing policy that aims to ensure that licensed premises have high standards of premises management?












## 8b. Anyone you know affected?

Do you know anyone who has ever been affected by gambling?





Is the policy easy to read?







Does the policy support the licensing objectives?




