Annex 1 - Mandatory conditions

1. Only individuals licensed by the Security Industry Authority may be used at the premises to guard against:
 - a) unauthorised access or occupation (e.g. through door supervision), or
 - b) outbreaks of disorder, or
 - c) damage

2. No supply of alcohol may be made under this licence
 - a) at a time when there is no designated premises supervisor in respect of it or,
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

3. Every supply of alcohol made under this licence must be made or authorised by a person who holds a personal licence.

4.
 - (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

 - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.

 - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either—
 - (a) a holographic mark, or .
 - (b) an ultraviolet feature.

5.
 - (1). A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.

 - (2). For the purposes of the condition set out in paragraph 1 -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979.

 - (b) "permitted price" is the price found by applying the formula where-
$$P = D = (D \times V)$$

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol.

(c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-

- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence.

(d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and

(e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994(7).

(3) Where the permitted price given by Paragraph (b) of paragraph 3 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

(4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the price permitted on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales and supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

6. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or

more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises—

- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or .
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise); .
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective; .
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective; .
 - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner; .
 - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
7. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
8. The responsible person must ensure that—
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
 - (i) beer or cider: ½ pint.
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and,
 - (ii) still wine in a glass: 125 ml.

- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and .
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.”

Annex 2 - Conditions consistent with the operating Schedule

1. The premises licence holder shall be security trained and SIA registered
2. There shall be at least one SIA-registered door supervisor on duty between 17:00hours and close on any day on which the premises is open to members of the public for licensable activities
3. Strictly only members and one bona fide guest per member shall be allowed entry to the premises
4. Any members wishing to sign in a guest must ensure that their guests name and home address is recorded in a book. The book is to be kept on the premises and available at all times
5. The premises shall operate a membership policy whereby.
 - a. No persons under 18 shall be permitted to be a member or be present on the premises after 17:00hrs
 - b. Prior to 17:00hrs, any person under 18 shall only be permitted entry if accompanied by a member
 - c. No person shall be admitted to membership, be described as a member, or afforded the privileges of membership(including access to the premises) unless at least 48hours have elapsed since that person's application to membership in writing
 - d. Any person wishing to become a member must apply in writing and provide with their application their full name, home address and a form of photographic ID (passport, driving licence or other official photographic ID) such that their details can be recorded and held at the premises in a register of members
 - e. The premises licence holder must ensure that a register of current members, including their full name, home address and a copy of their photographic ID is kept at the premises and is available to be inspected on request by a police officer or officer of the local authority
6. A search Policy shall be drawn up in agreement with the police Licensing team and shall be implemented whenever the premises are open for licensable activities. Information to be included in the policy shall include but is not limited to.
 - a. Regular searches of patrons upon the premises
 - b. All seizures of drugs and offensive weapons / firearms to be recorded in a register

- c. Immediate refusal of entry (and immediate cancellation of membership) to anyone found with any drugs, or offensive weapons / firearms on their person (such refusal to be recorded in the refusals log)
 - d. The disposal method of any seized goods, and specification of secure deposit box for such purposes, which deposit box must be kept locked and secured in a secure area to which customers have no access and shall be accessed only by the premise licence holder or police; every incident of accessing the box (whether to deposit seized items or otherwise) shall be recorded in the incident book
 - e. Access to the register to be restricted to management only at all times, with the names of those permitted access to be recorded and kept by the premises licence holder
 - f. A policy for notifying police of any seizures whether by 999 or 101.
7. The premises shall operate a 'behave or be banned, policy at all times.
8. The Premise Licence Holder shall ensure that reasonable and adequate staff training shall be provided, and proper records kept of training undertaken, including details of topics covered and those undergoing training. The training shall include, dealing with incidents, the prevention of crime and disorder, responsible alcohol sales (including underage persons, persons over 18 buying for minors, drunks etc) only those that have undergone training shall be permitted to sell alcohol at the premises
9. There shall be a CCTV system at the premises covering all public areas of the premises to a standard approved by the police
10. The Premise Licence Holder Shall ensure that all CCTV recordings shall be stored for a minimum of 31 days. Recordings shall be made available as soon as practicable following a request by a police officer or authorised officer
11. The premises shall operate a 'Challenge 25' or similar scheme whereby anyone who appears to be under the age of 25 shall be asked to provide proof of age that he/she is over 18. Proof of age shall only comprise a passport, photocard, driving licence or an industry approved proof of age identity card. Children under 18 are to be denied access.
12. The Premise Licence Holder shall ensure that any refusal of sale of age restricted products is recorded in a refusals log as soon as reasonably practicable after the sale is refused. The log should show the date and time of the event, the product sought, the gender and

approximate age of the customer and a description of the customer. The refusals log shall be kept at the premises and made available for inspection by the licencing authority, the police and trading standards officers

13. The Premise Licence Holder shall keep an incident log at the premises, which is to be made available for inspection by the police and authorised officers. It must be completed as soon as practicable after any incident and in any event within 24 hours of the incident occurring and will record the following where applicable.
 - a. All crimes reported to the management team of the premises
 - b. All ejections of customers
 - c. Any complaints of crime or disorder made to the premises
 - d. Any incident of disorder
 - e. All seizures of drugs and offensive weapons
 - f. Any faults in the CCTV system
 - g. Any visit by a relevant authority or emergency service

Annex 3 - Conditions attached after a hearing by the licensing authority

LRB – 30/11/2005

(Application partially granted due to Planning restrictions i.e. no licensable activity allowed after 23:00hrs. Therefore, late night refreshment licence not required)

- 1 . Any personal at the premises carrying out a security activity must be licensed with the Security Industry Authority.
- 2 . ID to be check at the door before entry.
3. Secure storage must be obtained for the storing of alcohol and must be to the satisfaction of the Police.

Police Review – 20/10/10

(LRB issued a formal warning to the PLH. LRB expects PLH's in the Borough to work positively with the Police and LA)

Additional condition imposed –

4. A Personal Licence Holder should be working within the premises at all times when alcohol is available for sale.

Appeal Hearing Heard on 20 March 2020 in relation to an expedited review on the 19 th August 2019 and Full review on the 10 September 2020 which resulted in the revocation of the licence
